Membership Process:

- Your application goes before the VAADA Board to be approved at its monthly meeting.
- Once approved a tax invoice will be issued for your membership fee and a Member Kit will be posted out.
- Pro Rata membership fees are applied for new members that join from August onwards in any given year.
- The Pro Rata membership is reduced according to the number of full months remaining in the membership year
- Membership is renewable on an annual basis (July 1)
