### About the role (Senior Counsellor)

The Senior Forensic AOD Counsellor (Senior Counsellor) will be responsible for providing secondary consultation and clinical supervision to the Forensic AOD Treatment team. The Senior Counsellor will also contribute to the leadership of our Forensic AOD Treatment team by facilitating the support and supervision of students and peer workers in the team.

The Senior Counsellor will hold a small case load and support clients by gathering information through assessment, formulating findings and recommendations, utilising strong report writing skills, developing realistic treatment plans, and delivering evidence based AOD Standard and Complex Counselling. The Senior Counsellor will engage with key stakeholders (internal and external) to continue to deliver on client outcomes across the Department of Justice and Community Safety, Courts Victoria, and Department of Health.

#### About the role (Forensic Counsellor)

Forensic AOD Counsellors work in a range of environments and locations in Victoria, ACSO offices, Department of Justice and Community Safety sites and Magistrates' Courts. Our Forensic Alcohol and Other Drug Treatment team provides Alcohol and Other Drug (AOD) treatment services to clients in contact with, or at risk of contact with the criminal justice system. The service is delivered face to face, via phone or video call.

Forensic AOD Counsellors are responsible for providing support to clients by gathering information through assessment, formulating findings and recommendations, utilising strong report writing skills, developing realistic treatment plans, and delivering evidence based AOD Standard and Complex Counselling. Forensic AOD Counsellors also regularly liaise and consult with Case Managers at the Department of Justice and Community Safety, and Courts Victoria and provide outcome feedback through client progress reports

- Bachelor level qualification in a relevant health discipline such as Social Work, Counselling, Psychology, Nursing or Allied Health Sciences, OR Diploma level qualification with substantial experience of 4+ years/specialised skills attained through previous appointments/service Certificate IV, or higher qualification, in Alcohol and Other Drugs (AOD) or have at minimum completed the core competencies, along with equivalent relevant experience.
- 2+ years prior experience in the AOD sector, including the delivery of treatment interventions and therapeutic approaches
- Holds registration with a regulatory health practitioner body such as AHPRA
- Strong demonstrated experience providing clinical supervision and secondary consultation
- Experience in leadership and an ability to work with challenging clients and complex issues, preferably in the AOD, forensic or Mental Health fields service Strong demonstrated experience in providing evidenced-based counselling (e.g., Motivational Enhancement Therapy and Motivational Interviewing, Cognitive Behavioural Therapy, Mindfulness-Based Relapse Prevention, Dialectical Behaviour Therapy, etc.) to clients tailored through assessment and formulation of client centred treatment planning

- A contemporary understanding of the biopsychosocial model of addiction and a sound knowledge of substances and their effects on human physiology, psychology, and offending behaviours
