## POSITION SNAPSHOT

The purpose of this position is to conduct fieldwork involving interviews and blood sample collection from participants in studies of drug use currently being undertaken at the Burnet Institute. Examples of these studies include:

- 'VMAX' – A prospective cohort study of people who use methamphetamine in Melbourne and regional Victoria.
- 'SuperMIX' – a prospective study of people who inject drugs in Melbourne.
- 'SIRX' – a prospective cohort study of clients of the Melbourne Supervised Injecting Room

The role is outreach-based, working at various locations around Melbourne. We're looking for someone who brings empathy, cultural humility and has experience working with priority populations.

The research assistant will conduct interviews with (and collect samples from) study participants; manage data collection; and, participate in the wider activities of the Alcohol and other Drug Research Group (Disease Elimination Program). Training will be provided in all aspects of the position (including phlebotomy if needed) and work will be undertaken under the supervision of the project investigators and senior members of the fieldwork team.

## KEY RESPONSIBILITY AREAS

1. PARTICIPANT INTERVIEWS	The Research Assistant will be responsible for locating study participants through initial recruitment methods, conducting follow-up using study databases, and interviewing them using computerised data collection forms as per study protocols.
2. SAMPLE COLLECTION AND TESTS	The Research Assistant may be required to collect samples such as venous blood samples, spirometry tests and colonisation swabs from participants as per study protocols. This includes the provision of appropriate pre- and post-test discussions around target health conditions such as blood borne viruses (e.g., hepatitis C).
3. DATA MANAGEMENT	The Research Assistant will be required to upload data and manage collected samples as per study protocols.
4. ETHICAL ENGAGEMENT	The Research Assistant will be required to abide by our ethics procedures as outlined in study ethics protocols and the Institute's Standard Operating Procedures.
5. OTHER RESEARCH TASKS	These include, but are not restricted to: liaison with external agencies, the provision of advice to other Institute staff, conference attendance and presentation, assisting or leading research on related projects (including report writing and technical assistance on research systems), attendance at program or group meetings.
6. TRAINING	Responsible for completing all required training in line with the position / role.
