#### **Position Summary**



The Alcohol and Other Drugs (AOD) Clinician provides innovative, evidence-based therapeutic interventions to both voluntary and forensic AOD clients. Tasks include undertaking comprehensive clinical assessments and delivering counselling and care and recovery support.

The AOD Clinician develops individual care plans to address assessed needs and implements the course of treatment in collaboration with the client. The position utilises a harm minimisation framework, working to reduce AOD related harm to individuals and their families.

#### **Position Context**

The AOD Clinician will work within the AOD team and report to the Manager of Alcohol and Other Drugs. It is also expected that the AOD Clinician works within the larger Primary Care Connect team and networks with external organisations.

#### **Key Performance Indicators**

- This position when full time, requires a minimum of 1380 contact hours per annum. Part time role is adjusted accordingly.
- Achieve the target levels of successful outcomes in line with funding and service agreement annually.
- Conduct a minimum of 5.5 hours contact time per business day.
- Develop individual care plans for clients using SMART goals.
- Meet 100% reporting requirements in accordance with quality service provision.
- Complete all data input required on internal and external databases in line with the Primary Care Connect Service Delivery Manual.
- Complete Victorian Alcohol and Drug Collection (VADC) data per episode of care.
- Connect with services both internally and externally to provide coordinated care to meet the client's diverse needs
- Conduct yourself in accordance with Primary Care Connects core values and behaviours

## Position Key Responsibilities and Expected Outcomes

Working under general direction, the role performs duties of a specialised nature in the application of knowledge and skills gained through relevant qualifications and previous experience in the discipline, and is expected to contribute knowledge in establishing procedures, and exercise judgement where procedures are not clearly defined.

- Undertake comprehensive assessments to obtain relevant information and history, with a focus on substance use and other co-occurring issues.
- Deliver enhanced support and care coordination functions for clients who are referred to the care and recovery program and present with varying levels of complexity.
- Provide person centred counselling that addresses the multiple needs of the client using integrated and holistic care.
- Complete comprehensive, factual case notes with all relevant documents and information for each contact with the client or stakeholders in line with service delivery manual requirements.



- Book ongoing appointments into outlook calendars and the data base.
- Respond to all client enquires from stakeholders within 24 business hours.
- Provide clients with a full account of engagement in a court support letter to the Magistrates Court of Victoria when requested.
- Always maintain client confidentiality.
- Develop and maintain strong internal and external relationships to support effective client pathways and outcomes
- Apply the principles of the Social Model of Health, taking a holistic view of client and community needs
- Participate in program evaluations as directed by management
- Address any non-compliance from file audits by the nominated due date
- Attend monthly meetings with the Operational Manager, AOD team meetings on a monthly basis as scheduled and all other meetings scheduled with Primary Care Connect and external stakeholders.
- Maintain a full understanding of the Child Safety Standards of Victoria
- Respond to family violence at an <u>intermediate</u> level by using the Multi-Agency Risk Assessment and Management (MARAM) Framework to identify and assess family violence risk, implement risk management strategies and refer victim survivors to services for family violence support.

- Excellent communication and interpersonal skills including demonstrated experience in liaising with a wide range of internal and external stakeholders.
